New Enrollment – Parent Acknowledgement

Education Code states that a student who has an IEP and wants to participate in independent study must have independent study specified as an instructional method in their IEP (ED Section 51745(c)). Independent Study requires students be able to demonstrate academic skills at/or near their grade level as well as to be able to engage with academic material without significant specialized academic support. All students must have been able to demonstrate willingness to participate and complete assigned work in order to attend, and be considered appropriate for placement in an independent study program, regardless of whether they have an IEP or not. A determination that independent study is appropriate must be written into the IEP within 30 days of enrollment.

The Vantage Point Charter School program requires a one-time per week meeting with a teacher to submit and receive weekly assignments. Transportation is not provided.

I have received and reviewed the Independent Study –New Enrollment – Parent Acknowledgement. I understand that if it is determined that the Vantage Point Independent Study program is not appropriate for my child, I will remain eligible to enroll my child in a school of the district in which I reside. I also understand and agree should this determination be made, I will immediately enroll my student in a program suitable for his/her identified needs.
